1. Voted YES to RC 165 — [Providing DOJ Over-Reaching New Authority via the “COVID-19 Hate Crimes Act” \(S 937\)](#) The COVID-19 Hate Crimes Act, by Dem. M. Hirono-HI, ACUF Lifetime 2%, provides overly broad authority to bureaucrats within the Department of Justice to advance the enforcement of “hate crimes.”
2. Voted **against** RC 39 — [Advancing an America First Agenda by Prioritizing Domestic Spending Over Foreign Aid.](#) The amendment would take \$26 billion in annual foreign aid for economic development programs and instead redirect the funds to domestic infrastructure projects.
3. Voted YES to RC 142 — Specifically, the bill continues to exempt Medicare from sequestration (2% cut) until 2022 at [a cost to taxpayers of \\$12.2 billion.](#)

Voted for RC 210 — Growing Government Bureaucracy by Establishing the Foundation for Energy Security and Innovation (S 1260) This amendment creates a quasi-government non-profit known as the Foundation for Energy Security and Innovation (FESI) which is directed to “accelerate the commercialization of energy technologies” (i.e., “green” energy) and [would cost taxpayers \\$30 million in 2023](#) and likely much higher amounts in future years.

Is or was President and Chief operating officer for Chickasaw Bank owned by Chickasaw Nation

Shannon was an Oklahoma House of Representative, District 62, starting in 2006-2014 to run for U.S. Senate vacant by Tom Coburn (R) retirement and lost. Republican primary June 24, 2014.

T.W. name is listed on McGirt Case among attorneys for the Indian Tribe defending a convicted Violent Rapist of a 4yr old child, Jimcy McGirt vs Oklahoma for the tribes against Oklahoma. The US Supreme Court reversed his conviction due to claim crime was done on Indian land and OK court had no jurisdiction. He was hired by the Senate in Sept 22, 2020 to help with redistricting the state as their Public Liaison. He was to be paid \$6,250 on a month to month contract. Shannon is President and Chief Executive Officer of Chickasaw Bank owned by the Chickasaw Nation in OKC. Shannon earned his B.A. from Cameron University and Law Degree from OSU.

**Running for the COMMISSIONER OF LABOR**

**(ACU) Conservative 2018 – 61%; Lifetime – 61%**

**OK Constitution 2018 – 21%; Lifetime – 48%**

Leslie is the incumbent Oklahoma Commissioner of Labor on January 14, 2019, term ends on January 9, 2023. Osborn is a former Republican member of the Oklahoma House of Representatives, representing District 47 from 2008 to 2018. Her performance in the House was extremely low, actually more liberal. She didn't VOTE for multiple key conservative votes! **She missed 25 VOTES in 2017-2018 alone**, thus not representing OK people in her district, showing lazy and disinterest in her position.

If to look at her voting in 2017-2018 mostly she voted for TAX increase, increase in government spendings and control.

She voted AGAINST bill HB 3016. This bill requires the informed consent of a parent or guardian before a health-care provider administers a vaccine. The parent must be informed of the benefits and risks of the vaccine.
