Section 9E. CREATES NEW SECTION TO STATE CONSTITUTION

A. There are hereby created public infrastructure districts.

B. <u>Municipalities may approve the creation of public infrastructure districts</u>, which <u>may incur indebtedness</u> and issue public infrastructure <u>district bonds</u> to pay for all or part of the cost of public improvements within such districts. <u>The cost of all indebtedness so incurred shall be levied and assessed by the board of trustees of a public infrastructure district on the property benefited by such improvements following the passage and approval of the organization of a public infrastructure district pursuant to subsection C of this section. The (UNELECTED) board shall Collect the Special Assessments so levied (not the tax commission) and use the same to reimburse the public infrastructure district for the amount paid or to be paid by it on the bonds issued for such improvements not to exceed ten (10) mills for the purpose of providing funds for the purpose of support, organization, operation, and maintenance of such services.
C. A public infrastructure district shall not be created unless a petition is filed with the municipality that contains the signatures of one hundred percent (100%) of surface property owners (mineral owners pay nothing)</u> within the applicable area consenting to the creation of the public infrastructure district (and can affect property for 20 yrs or more.)

F. The Legislature shall be authorized to enact such laws as may be necessary in order to implement public infrastructure districts in this state. (This is giving your control over to a group of people with no say or vote)

<u>VOTE NO</u> – <u>Will STOP more DEBT</u>, <u>STOP MORE TAXES</u>, STOP Control of Your Property. <u>VOTE YES</u> – Will ALLOW more DEBT, Increase Taxes, Another Layer of government.
