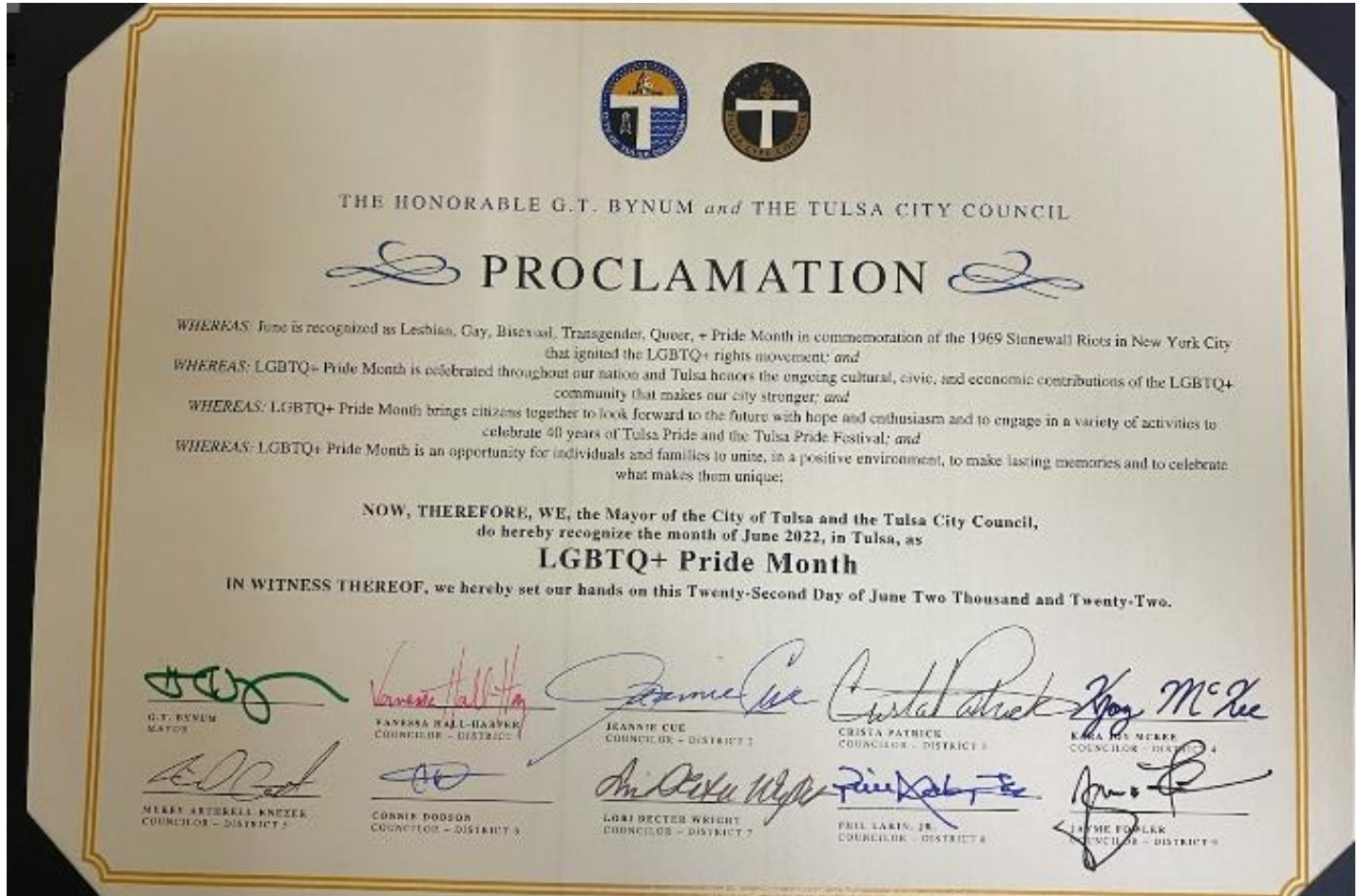


RUN-OFF for TULSA MAYOR AND CITY COUNCIL ELECTION

ON June 22, 2022, meeting and again June 2024, the Mayor and ALL City Council Signed and Presented PROCLAMATIONS from Tulsa City to the LGBTQ+...Z without the People of the Tulsa City approval. TULSA PROPOSITION NO. 1 PROPOSED CITY CHARTER ADMENDMENT (RAISING) CITY COUNCILOR'S SALARIES, Aug 27th, 2024.

2023 City of Tulsa Employees' Salaries:

1. City of Tulsa Average Salary is 113% higher than the OK State Average
2. City of Tulsa Employees number in year 2023 was 3,669.
3. City of Tulsa average salary was \$72,138 with highest paid was \$234,316 who was City Physician?
4. Top 10% of highest-earning employees' salaries range \$103,348 - \$234,316
5. Tulsa Mayor was paid \$105,000. This salary was 46% percent higher than average and 52% higher than the median salary in City of Tulsa.
6. The city physician (Phil Berry), the city attorney, the police chief, and the Public Works director each make more than \$190,000, according to city records.

PROPOSED Charter Change Wording: That the Amended Charter of the City of Tulsa, Oklahoma, Article II, "The Council", Section 2, "Salaries", be amended by deleting the previous annual salary (\$24,000.00) and replacing it with a new annual salary of Thirty-Two Thousand Dollars (\$32,000.00), **allowing periodic adjustments as certified by the City Treasurer consistent with the Consumer Price Index for All Urban Consumers (CPI-U) issued by the U.S. Bureau of Labor Statistics;** withholding any salary adjustment until the next following Council term; forbidding the City Council to change its own salary without such certification by the City Treasurer; and allowing reimbursements to Councilors for appropriate expenses.

This Amendment *Raises Salaries of the city council 33%* (\$24,000 TO \$32,000) PLUS allows periodic INCREASES (can start next year) by City Treasurer, based on National Salaries, NOT on LOCAL, PLUS ALLOWS Reimbursements to Councilors for "APPROPRIATE" expenses, starts December 2, 2024.

(OKC pays \$12,000 to City Councils and \$12,000 to MAYOR (more population), Tulsa pays \$105,000 to Bynum.

VOTE NO - STOPS the SPENDING, as Tulsa Salaries are 113% higher than OK Average!
PLUS gives VOTER CONTROL of Salaries over to the City.

VOTING YES - ALLOWS THE CITY TO CONTINUALLY RAISE SALARIES, WITHOUT LIMIT, and adds
ADDITIONAL EXPENSES which city says is "appropriate?" **Will ULTIMATELY RAISE TAXES**

TULSA PROPOSITION NO. 2 PROPOSED CITY CHARTER ADMENDMENT (RAISING) CITY AUDITOR'S SALARY

Charter Change Wording: A PROPOSED AMENDMENT TO THE AMENDED CHARTER OF THE CITY OF TULSA, OKLAHOMA, ARTICLE IV, "THE CITY AUDITOR", SECTION 2, "SALARY"; DELETING THE PREVIOUS ANNUAL CITY AUDITOR'S SALARY OF SEVENTY PERCENT (70%) OF THE MAYOR'S SALARY; **REPLACING IT WITH AN ANNUAL SALARY OF SEVENTY-FIVE PERCENT (75%) OF THE MAYOR'S SALARY.**

The AUDITOR is currently getting paid \$73,500 dollars (70% of %105,000 TO 75%) and increasing his pay by 7.2% (high increase). With higher property tax, groceries, gas, utilities, expenses, and Salaries already 113% higher than State Average, the Spending Needs to STOP.

VOTE NO STOPS the SPENDING, Tulsa Salaries are 113% higher than Oklahoma State Average! **PLUS gives VOTER CONTROL of Salaries in the City.**

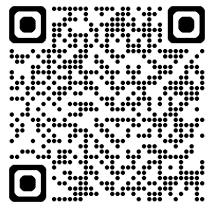
BRENT L. VanNORMAN, 64, REPUBLICAN CONSERVATIVE

Brent is an CPA, an attorney and businessman who helped build Tri-Linc Law Firm (Past President), and a Pastor, who pastored a church for 10 years. Brent graduated in Accounting & Computer Science, magna cum laude, from Anderson University in Indiana, awarded Outstanding Accounting graduate and Graduated with a Law Degree, summa cum laude, from Regent University School of Law, Awarded Outstanding Law Graduate. Brent was an adjunct law professor at his alma mater. Brent served on two Board of Directors of IMPACT International, a non-profit, from 2004-2014, and CCG Systems, Inc. since 2015. **Brent's Main focuses:** "Making **Tulsa more business-friendly by expediting permits, improve safety by hiring more police officers**, help prevent homeless population from growing, and **to remove socialism from our city. According to court documents from the civil lawsuit, in March 2020, the State Health Department paid \$2.1 million to PPE Supplies, LLC, for masks for Covid in Tulsa. There is a money trail from the company Casey paid for the shipment of masks from China, but the masks went to another country, plus Casey did pay back some of the money, retrieving the rest of the money in federal court from the foreign company. Kaleb Hoosier, 32, was arrested in the morning on Friday, March 2nd, 2024, on Taft Ave in Sapulpa, with his hazard lights on. Sapulpa Police spoke with Hoosier and could smell odor of alcohol, Kaleb was slurring his speech and unsteady on his feet which led police to believe he was possible drunk. Upon being asked to step out of the vehicle, Hoosier picked up a 9mm pistol and began to exit his car with the pistol in hand. Both police drew their weapons and ordered Hoosier to drop his gun, get on ground, and did so without resisting. Police found the seven rounds in the magazine, plus one in the chamber, & more ammo in glove box, plus an open beer can, according to the affidavit. Hoosier initially agreed to take a blood test, but then refused at hospital. Police arrested him and noted that Hoosier had previous drug-related charges in Tulsa County in 2007 and 2009. 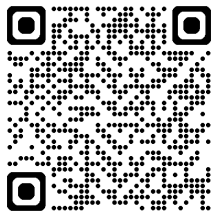

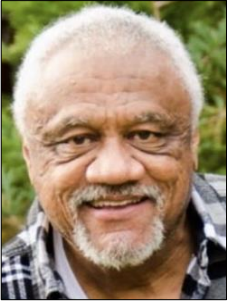

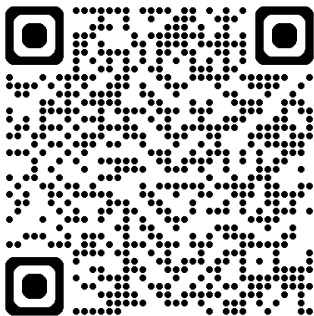
