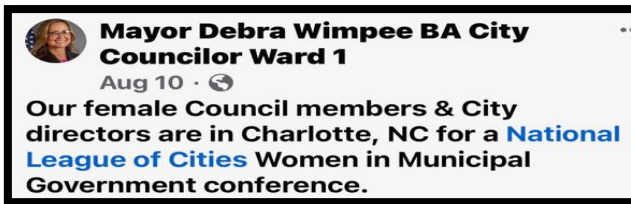

The measure would amend Section 1 of Article III of the [State Constitution](#).

#### Oklahoma Constitution Article 3 – Suffrage: Original Below

##### Section 1. Qualifications of electors.

Subject to such exceptions as the Legislature may prescribe, **all citizens** of the United States, over the age of eighteen (18) years, who are bona fide residents of this state, are qualified electors of this state.

The following struck-through text would be deleted and underlined text would be added:

##### Section 1. Qualifications of electors.

Subject to such exceptions as the Legislature may prescribe, **all only citizens** of the United States, **who are** over the age of eighteen (18) years, **and** who are bona fide residents of this state, are qualified electors of this state.

Municipalities may approve the creation of public infrastructure districts, which may incur indebtedness and issue public infrastructure district bonds to pay for all or part of the cost of public improvements within such districts. The cost of all indebtedness so incurred shall be levied and assessed by the board of trustees of a public infrastructure district on the property benefited by such improvements following the passage and approval of the organization of a public infrastructure district pursuant to subsection C of this section.** The board shall collect the special assessments so levied and use the same to reimburse the public infrastructure district for the amount paid or to be paid by it on the bonds issued for such improvements not to exceed ten (10) million for the purpose of providing funds for the purpose of support, organization, operation, and maintenance of such services.

C. A public infrastructure district shall not be created unless a petition is filed with the municipality that contains the signatures of one hundred percent (100%) of surface property owners within the applicable area consenting to the creation of the public infrastructure district.

**F. The Legislature shall be authorized to enact such laws as may be necessary in order to implement public infrastructure districts in this state.**
