C. A public infrastructure district shall not be created unless a petition is filed with the municipality that contains the signatures of one hundred percent (100%) of surface property owners within the applicable area consenting to the creation of the public infrastructure district. (Signing voluntarily offers Your Land for Levy and Tax purposes)

F. The Legislature shall be authorized to enact such laws as may be necessary in order to implement public infrastructure districts in this state. (MAKE LAWS YOU have NO say on or KNOW ABOUT)
