2) **He Sued A NEW Catholic Charter School because of their faith**, in OK Charter School v. Drummond, challenged contract allowing a Catholic school to be charter school, **opposing religious freedom in school choice in the OK Supreme Court Case.** OK SUPREME Court ruled with AG. 3) **Fought Trump Admin at US Supreme Court over School Choice - U.S. Supreme Court Key ruling Carson v. Makin (2022), 6-3 Vote affirming Parental Choice in school choice include religious schools,** ruled **States cannot Discriminate against Religious options in Educational Choice Plans. (overturned Catholic Charter School case)**

4) **Upon request from Sen Deever & Sen. Hamilton & seven other legislators, Drummond refused to enforce a state statute outlawing “self-managed” abortions using abortion pills.** 5) **Drummond Neutered Bill 212** passed against China/Foreigners owning land in OK. Drummond redefined term **“bonafide resident”** to describe **“anyone with the intent to become a legal resident”** as a way to circumvent the law.

6) Alarming- Gentner did not **launch prosecutions** or **criminal investigation against OKDHS Ok Depart of Human Service** with **multiple whistleblower complaints, public petitions, & investigative coverage**

12 He dodged Eric Swalwell’s **question on Trump’s 2 impeachments.** He said: **“That’s outside my lane”** on 1st impeachment, **“I don’t have an opinion”** on 2nd impeachment. [See video](#)

12) Gave disgraced State Rep. Ty Burns, only a misdemeanor, instead of a felony charge, after arrest for assault violence, he attempted to gouge his wife's eyes out & run his own daughter off road.

21) Former Cleveland County Sheriff Chris Amason, was indicted on four felony counts tied to campaign and taxpayer funds, moving thousands from his campaign to himself, & was using taxpayer money to send his wife to out of state conferences. His office reached a plea deal of NO jail time, \$10,000 restitution, allowed Amason to resign, with a five-year deferred sentence from Drummond’s office. [See article](#)

23) **He received 1.7mil & 1.9 mil for a total of \$3.6 million in COVID PPP relief funds** for his various businesses. Some of those loans were administered through Blue Sky Bank, he is a % owner, earned the bank around \$70k in fees and interest, before the loans were eventually forgiven by the federal government. SB 1206 Taxpayer-Funded Marketing Promotion - bill permits municipalities to tax hotels with 50 or more rooms in order to fund marketing promotions for private and public events. (Marketing & taxing hotel owners is not the Job of Congress or cities!)**

**SB 839 – Taxpayer Funding of Museum of Popular Culture for 25 Million. (All Museums should be private funds/Not gov.)**

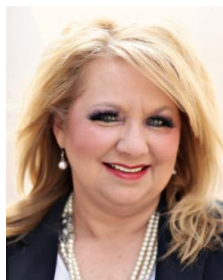
